FIRST YEAR

I. TERM (FALL)

SHZ103 Introduction to Social Work (3+0)3 ECTS: 5

Definition of Social Work, Main Purpose, Fields, Importance, Role and Functions, Distinctive Features, Basic Concepts and Approaches Related to Social Work, Social Welfare, Social State, Social Work Theories, Interdisciplinary approach, Relationship of Social Work with Other Disciplines, in the World and Turkey in Social Work, Social Assistance and Solidarity Organizations, Methods of Social Work, Social Work and Value, Social Work and Ethics.

SHZ101 Introduction to Sociology (2+0)2 ECTS: 4

This course covers the basic concepts of sociology, such as society, social structure, social change, culture, cultural change, family, social stratification, role, status, social mobility, economy, globalization, religion, politics, media.

PSG103 Introduction to Psychology (2+0)2 ECTS: 5

Basic concepts and theories of psychology, goals, Approaches in Psychology, Research Areas, Building blocks of the brain, thought, language, motivation, emotions, infancy, childhood, adolescence, adulthood, Social psychology, Clinical psychology and mental health.

HUK101 General Law (2+0)2 ECTS: 4

The field of law as a social science, social order, rules of law, the principle of the rule of law, definition of law, the importance and principles of law in social life, rules and other social rules regulating social life, sections of law and branches of law that fall into this section, types of legal rules, implementation To provide students with information about the Turkish Judicial System and its interpretation.

TURK101 Turkish Language I (2+0)2 ECTS: 3

What is Language, Theories about the birth of language, Language-culture-nation relationship; Language Revolution: Turkish Language Institution and its studies; Languages of the World: Language families, the place of Turkish among the world languages; Features of Turkey Turkish: Phonetic features, Form features, Sentence features; Writing rules; Punctuation; Correspondence: CV, Petition, Letter, Business letter, Telegram.

ATA101 Atatürk's Principles and History of Turkish Revolution I (2+0)2 ECTS: 3

Recession of Ottoman Social and State Order and Reform Movements; The Disintegration of the Ottoman State and the Beginning of the National Struggle; Mustafa Kemal Pasha's Organization of the National Struggle in Anatolia; Opening of the First T.B.M.M.; Military and Political Developments Between 1920-1922; Revolutions and Counter-Reactions; Establishment of the Constitutional System; Domestic and Foreign Politics in the Republican Era; The Basic Features of the Turkish Revolution and the Thought

Movements Affected by it; Innovations in Law, Education, Economy and Social Life; Atatürk's Principles and General Characteristics of These Principles; Evaluation of Kemalism in Ideological Perspective.

II. TERM (SPRING)

SHZ124 Rights of Disabled Persons and Social Work (2+0) 2 ECTS: 4

Conceptual framework for the disabled, Classification of disability, Social work intervention for the disabled, Contemporary service models for the disabled, State policy for the disabled, Social attitudes towards the disabled.

SHZ104 Social Work Institutions (2+2) 3 ECTS: 6

Observation in Social Work Institutions course basically tries to describe the existing practices in social work institutions by observing, they get information about the institutions and practices in these institutions. At the end of the visits, the observations and reports written by the students are discussed in groups.

SHZ106 Social Problems (3+0)3 ECTS:5

A social problem refers to an undesirable situation that affects a significant part of the society, and solving social problems requires the society to take responsibility collectively. In this sense, the social problems course is a course about gaining the necessary competence in order to learn, analyze and propose solutions to the basic problems existing in society. SHZ108 Social Work With Elderly (2+0)2 ECTS: 4

It covers the old age period and the problems encountered, care services and services carried out in terms of social work.

RPSI209 Positive Psychology and Communicaton Skills (USEC) (2+0)2 ECTS: 3

Definition of Positive Psychology-concepts, theoretical foundations of positive psychology, brain infrastructure of social behavior, positive psychology practices, self-knowledge and awareness, knowing others and empathy, psychosocial life skills, motivation and planning, problem solving skills, anger, aggression and violence, relationship management, perseverance, sound decision making, compromise.

INGU102 English II (3+0)3 ECTS: 3

Tenses: Present tense, Present tense, Past tense, Future tense structures; Modes: Might, Could, Can, Must, May; Adverbs: Place, Direction, Purpose, Adverbs of State; Adjectives: Order of adjectives, Comparison, Superlative structures; Passive Structure: Present, Extended, Past, Future passive structure; Conditional Phrases; Adjective Phrases; Transfer Sentences; Verb Structures: TO, -ING; Noun Phrases; Adverb Phrases; Comparative Structures.

TURK102 Turkish Language II (2+0)2 ECTS: 3

To gain the ability to use the mother tongue correctly; Punctuation marks and spelling rules, composition rules, writing types are discussed with examples in the course, where it is essential to generate ideas and write their thoughts in order to improve the abilities of the students who came to the university by gaining this skill. In addition, various novels, poetry books and theater works are read and studied. A reading theater is made in the classroom and applied emphasis and intonation lessons are given with various diction techniques.

SECOND YEAR**III. TERM (FALL)****SHZ205 Local Governments and Social Work Management (2+0)2 ECTS: 3**

What are the concepts of central government and local government? What are the types of Local Government? What are the national legislation on local governments, and what are the activities of local governments in the field of social assistance and social work? What are the problems and solution suggestions in social assistance and social work practices? Benefits of local governments in service delivery, social risk, stakeholder institutions and organizations, local governments, NGO cooperation, objectivity in local government and social service practices.

SHZ203 Social Work Practice I (2+8) 6 AKTS: 10

It is aimed to familiarize students with social work practice areas under the supervision of a lecturer. In this course, students get information about social service organizations and the practice environment of social work and the practices in these institutions by doing an internship in institutions once a week. At the end of the visits, observations and reports are made by the students.

SHZ235 Introduction to Anthropology (2+0)2 ECTS: 4

It is enriched with examples by giving theoretical information on the definition, principles, historical background, fieldwork methods, and cultural relations of anthropology. Within the scope of the course, the characteristics of culture, cultural processes, ethnicity and race, livelihoods and economy, family and kinship systems, gender and political anthropology and social anthropology are covered.

SHZ207 Interviewing Principles And Techniques In Social Work (3+0)3 ECTS: 5

Interviewing as a professional narrative technique. Cultural differences between the client and the interviewer in the interview. The importance of interaction and mutual relations in negotiation. Psycho-social analysis, evaluation of the interview and reports. Interview examples. Individual, family and group interviews.

SHZ209 Social Work With Families and Children (BSEC) (3+0)3 ECTS: 4

Social work intervention to strengthen the family, planned change process in the family; The characteristics of childhood and adolescence, the needs and problems of children, the examination of economic, social and psychological problems related to neglect abuse of children, positive change practices of social work with children and their families

ADS211 Sign Language I (BSEC) (0+2)1 ECTS: 3

Definition of Turkish Sign Language (TİD), Hand and finger shapes, position of the hands relative to the body, function of gestures, Use of single and double hands, relationship between signs and Turkish, Sign meaning, original expression, Hand-body harmony, facial expression-message harmony, Greeting, asking for help, Communicating with the hearing impaired individual using TİD, Transferring feelings and thoughts, Exercise: Music practice with sign language

IV. TERM (SPRING)**SHZ228 Social Work Legislation (3+0)3 ECTS: 4**

Definition and importance of legislation, legislation of social service institutions: Laws; Law No. 2828 and its importance, Law No. 5395 on the protection of children and its importance, Law No. 633 on the Organization and Duties of the Ministry of Family and Social Policies, Republic of Turkey. Relevant articles of the Constitution, Laws enacted for the disabled, elderly, women and children

SHZ200 Social Work Practice II (2+8)6 ECTS: 8

Social work with individuals, Social work with refugees and asylum seekers, Social work in Disaster and Emergency Situations, Urbanization and Urban Problems and Social Work, Poverty and Social Work, Substance Abuse and Social Work, Research Methods, Preparing a Research Report

SHZ232 Social Structure of Turkey (2+0)2 ECTS: 4

In the process from the Ottoman Empire to today's Turkey, various elements of the social structure are examined in general terms and discussed critically. Within the scope of the course, culture, education and religion in Turkey, Turkey's economic structure and social transformation are covered.

SHZ202 Social Work Ethics (2+0)2 ECTS:3

After an introduction to the main issues of moral philosophy, all major ethical approaches will be examined one by one. In this framework, Kantian ethics of duty, utilitarian ethics, feminist ethics and Aristotelian

ethics will be discussed. Then we will move on to the subject of professional ethics. Finally, by discussing cases from the social work profession that are the subject of ethical debates; Students will be provided to apply and discuss the concepts of ethics in concrete events.

SHZ999 Summer Internship (0+20)0 ECTS 9

It covers 20 working days during which students will perform their professional practices.
